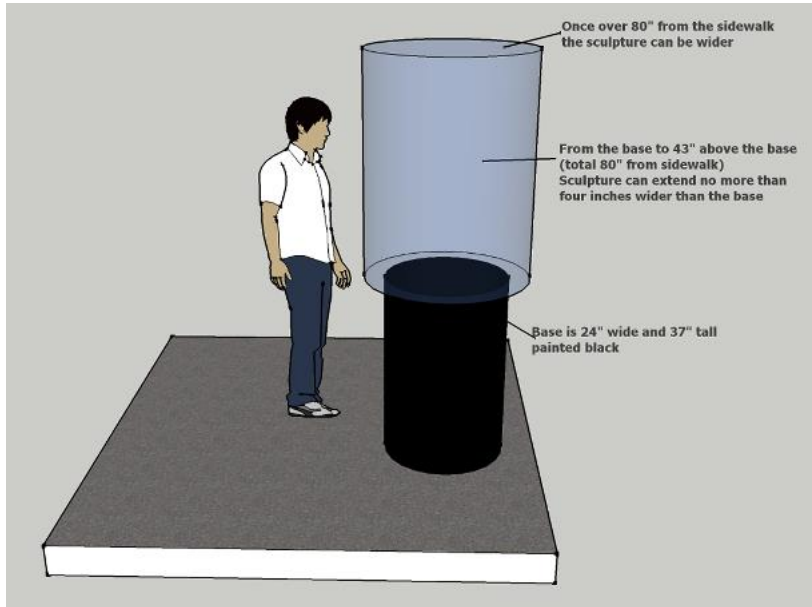


# Palisade Art Vision

**Key components of contract:**

Artist will receive a \$500 stipend for the work to be displayed for approximately one-year awarded on Saturday, Sept 9<sup>th</sup>, 2017. Artist is responsible for transportation of the work and assistance in installation. The artist certifies that his/her artwork is original and available for purchase. The artist certifies that works are soundly and professionally constructed of durable and sturdy materials, have no breakable or easily damaged parts or pieces, are suitable for public outdoor display, are constructed in a way which will not cause safety or liability problems, and will not require any additional maintenance or cleaning during the one-year display period. PAV is responsible for securely installing all art work. The Town of Palisade shall obtain and maintain general liability and property casualty insurance coverage. PAV reserves the right to make all installation/placement decisions and to make emergency repairs to works when necessary, with consultation from the artist. PAV will make a reasonable effort to market works exhibited and distribute informational materials. The artist agrees that PAV will handle all sales and that PAV will retain a 25% commission for any artwork purchased during the exhibit period, or as a direct result of this exhibit.
